Candidates for Governor



Tony Evers

“Research also indicates that early childhood education and after school programs have been shown to reduce crime and improve outcomes for kids. I would support additional investments in evidence-based programming, our public schools, and our local governments as an effective way to improve public safety and strengthen our communities.”¹

Crime

“I am vetoing Assembly Bill 970 in its entirety. This bill eliminates income limits and participation limits in the Parental Choice Programs...”³

School Choice

“I’ll keep fighting every day to defend reproductive rights and access to abortion as long as I am governor.”⁵

Abortion

“Overall, the budget approved by lawmakers spent billions less than Evers called for and omitted major proposals from the governor, including legalizing marijuana, expanding Medicaid and raising the minimum wage. It also included a \$3.4 billion tax cut the governor didn’t propose.”⁷

Taxes/ Economy

“One of the most important facets of people participating in a democracy is voting. And if we make it more difficult for eligible people to vote, that’s a problem for me and I think it’s a problem for everybody. So I will be vetoing those bills that fall into that category.”⁹

“We will make sure that we get the right funding, we will make sure that we back the blue, we will make sure that the laws on the books are enforced.”²

“I support school choice for all Wisconsin families.”⁴

“I’m prolife. It comes from my faith. I believe we have to protect the unborn. There’s two victims when you have an abortion. There’s the unborn baby and then there’s the mother... The 1849 law is an exact mirror of my position, and my position is an exact mirror of the 1849 law.”⁶

“Wisconsin needs a governor who won’t stand in the way of economic growth. The Michels Administration will provide all businesses with the best opportunity to succeed and grow operations in Wisconsin. I won’t ever dictate if a business is essential or non-essential, because in the Michels Administration, we will make clear that all work is essential.”⁸

“Our plan is simple, we need to make it easier to vote, and harder to cheat. Politicians in Madison have made a mess of our elections, and I won’t let that continue. This is a Wisconsin Voter Protection Plan, plain and simple.”¹⁰

Candidates for Attorney General



Josh Kaul

“Josh supports expanding background checks, creating extreme risk protection orders, prohibiting ghost guns, and increasing the felony classification for repeat felon-in-possession and straw purchasing offenses.”¹

“The Attorney General is responsible for defending state law, including issuing opinions to clarify the law or filing lawsuits to defend our election laws. As Wisconsin’s Attorney General, I will fight to ensure all ballots are treated equally throughout our state, regardless of what county they are cast in.”⁸
