In a recent email we shared some resources with you. Here are three that you won't want to miss.

1. On January 26, the group "Parents on Patrol" hosted a panel discussion of what transgender activists are pushing on our children. The panelists were not evangelicals! One is a single mom who identifies as a radical feminist. One is a man living as a transgender woman. One is a young woman who pursued a transgender identity but subsequently de-transitioned. And one who joined via Zoom is a clinical therapist. You will disagree with and dislike some things that are said, but because of God's common grace, these folks are speaking up in defense of children and in opposition to the transgender movement. They have important things to say, and they are worth listening to. On February 15, Wisconsin Family Council's Church Ambassador Network hosted a webinar with Katy Faust, author of *Them Before Us*, a book which promotes the interests and needs of children above the desires of adults. The main thrust of her book is that children have a right to be loved, raised, and known by their biological parents. She makes a strong case against a number of "alternative" family structures, including arguing against divorce, same-sex marriage, surrogacy, etc. We think this was one of our best webinars ever.
