Dear Pastor,

We hope that you value the ministry of Wisconsin Family Council in our state. As it happens, there is no other statewide organization whose mission is strengthening, preserving, and promoting God's design for marriage and family, the sanctity of human life, and religious freedom. Our Church Ambassador Network initiative is the only ministry in Wisconsin directly connecting pastors and churches to governing authorities to advance God's kingdom as we minister to them as a person, a shepherd, and a community partner. Our LEAD Wisconsin teen ministry hosts the only camp in the state focused on equipping the next generation with a biblical worldview. Our feet are planted solidly on the truth of God's inspired, infallible, revealed Word on these matters.

Our heart is that we are not just a "para-church ministry" but that we are a **pro-church ministry**. Because we believe in the primacy of the local church. We firmly believe you are God's "Plan A" to impact our culture. This is why at our events when we invite folks to consider supporting us, we regularly remind them that we believe their first obligation is to support their local church and that if God enables them to give over and above their local church giving, we ask them to prayerfully consider supporting us.



That said, we rarely make a plea to pastors and churches to financially support us.
